CALL SURREALE

Application call 2023



The Società Ginnastica di Torino / FLIC Circus School is the organising body behind "Surreale – contemporary circus residencies", which is supported by MIC (Ministry of Culture) and the Region of Piedmont within the project "Artisti nei Territori". The aim of this residency programme is to identify potential circus projects which to support, within its individual programme of artistic residencies for the year 2023.

RESIDENCY CONDITIONS

Art.1 – Objective of the Residency Call

The purpose of the call is to identify contemporary circus companies and artists (who are Under 35) who know how to interpret **circus language** in a contemporary, innovative and multidisciplinary way, through the use of different scenic and narrative languages.

Art. 2 – Who can participate

The call is aimed at:

- **Companies** who come from the European territory, who wish to develop a full-length show;
- **Single artist(s)** (who are Under 35) who come from the European territory having the desire to develop a project in a short form of 20 minutes. Priority will be given to projects composed of single or duo artists.

Companies and entities with formal Artistic Residency programmes are excluded from this call.

Art. 3 – Deadlines and schedule

The projects must be sent by e-mail according to the terms illustrated in art. 7, no later than **14th of April 2023 at 23:59 GMT +1.**

Art. 4 – The selections

Projects received by email will first be evaluated by a committee composed as follow:

- Lo Prete Matteo – Director of Reale Società Ginnastica di Torino and FLIC Scuola di Circo
- Stevie Boyd – Artistic Director of FLIC Scuola di Circo
- Giovanna Milano - Cultural project manager of FLIC Scuola di Circo and Artistic Curator of Spazio FLIC show season

After a first selection in which n. 6 Under 35 projects and n. 4 Companies will be chosen from among all the participants, a second selection will be made, in which a Commission composed of representatives of the TALEA network (Dinamico Festival, Circo all'Incirca, Magda Clan, Cordata F.O.R., Fabbrica C and Quattrox4) will participate as experts and select the winning projects.

The criteria of judgment will be the the quality of interpretation, the contemporary aesthetic, the dramaturgical interest, the multi inter and trans disciplinary feature of the project, the theme in relation to the realization, the artistic and / or the training curriculum.

A maximum of 3 projects by single artists (Under 35) and a maximum of 2 companies will be awarded, at the sole discretion of the commission.

Art. 5 – Support available to the winners

The individual artists (Under 35), be they single or duo artists, will receive:

- 15 days of artistic residency in 2023 (dates to be defined) at Spazio FLIC in Turin;
- a NET sum of € 1900.00 as support for the creation;
- a NET sum of € 1000,00 for tutoring.

The short forms selected to be presented in 2023 within the FLIC Circus School's show season @Spazio FLIC 2023/2024.

Companies selected will receive:

- 15 days of artistic residency in 2023 (dates to be defined) at Spazio FLIC in Turin;
- a NET sum of € 6000.00 as support for the creation, which will include food, accommodation and travel;
- a NET sum of € 1000,00 for tutoring.

By residency, it is meant as a working period of 15 days, not necessarily consecutive, at Spazio FLIC, which is an open space of 700 square meters, equipped for circus disciplines, with changing rooms, showers and bathrooms, and is equipped with audio and stage lighting.

In the event that the commission deems that the submitted projects do not meet the artistic criteria of the call, the commission may choose, at its sole discretion, to select less than 5 projects or no project at all.

Art. 6 – Obligations of the companies /artists

Companies and Artists who are Under 35 selected are required to guarantee their presence for the 15 days artistic residency during the period between July and December 2023, to be agreed upon based on the activities timetable of FLIC Circus School.

Companies and Artists (Under 35) selected are required to indicate, in all public and promotional materials related to the selected project, the words: "with the support of RSGT / FLIC - Residenza Surreale".

Art. 7 – Procedure for participation in the residency call

To participate in the residency call, it is necessary to send the fully completed Participation Form to the email address **info@flicscuolacirco.it**; using the subject title "Call Surreale 2023" and sending by no later than the **14th of April 2023 at 23:59 GMT +1.**

Mandatory attachments are also required: project description, curriculum vitae of the artist, valid identity document of the project manager and the legal representative of the company. Participants can send other descriptive, poetic, photographic and video material to support the application.

Art. 8 – Communication of the results

The outcome of the selection will be published by the **2nd of May 2023** on the FLIC Circus School's website www.flicscuolacirco.it. The Companies and Artists Under 35 selected will receive a direct communication to the email addresses indicated in the Application Form.

Art. 9 – Privacy

The data collected for this call will be processed in accordance with Italian Legislative Decree, 30 June 2003, n. 196 "Code regarding personal data" and the GDPR (European Regulation 2016/679).
